# Personal Guaranty of Corporate Obligations

In order to induce EFI to extend credit to Buyer, the undersigned Guarantor guarantees the payment to EFI of all sums which may be presently due and owing and of all sums which shall in the future become due and owing to you from Buyer, on account of goods and/or services sold and delivered by EFI to Buyer.

The liability of the Guarantor hereunder shall include, without limitation, reimbursement and indemnification, on demand, of all costs and expenses (including court costs and legal expenses) incurred or expended by EFI in connection with the collection of any amount due from Buyer and/or the enforcement of, this Guaranty.

Guarantor also agrees that this Guaranty shall not be impaired by any modification, supplement, extension or amendment of any contract or agreement to which EFI and Buyer may agree, that this guaranty is a continuing Guaranty which shall remain effective until expressly terminated as hereinafter provided; and that nothing shall discharge or satisfy the liability of the Guarantor hereunder except the full payment and performance of all Buyer's debts and obligations to EFI.

Guarantor waives: notice of acceptance hereof, presentment and protest of any invoice or instrument, and notice thereof. This is a direct obligation, which EFI may enforce without first suing or obtaining judgment against Buyer.
